PARLIAMENTARIAN'S REPORT

Welcome to the new senators! You do not have to be an expert in parliamentary procedure to be a senator. Here is what you need to know to get started:

- The two main purposes of the rules of order are:
 - To make the meeting run quickly when there is consensus, and
 - o To make the meeting run slowly when there is not consensus.
- How to raise a Point of Information (also called a Point of Inquiry).
 - You use a Point of Information to learn how the rules can allow you to do what you want.

- You do not need to raise your hand or be called on for this. You unmute yourself and say "Point of Information" or "Point of Inquiry." You ask the President the question. The President can answer it or ask me to answer it.
- You are allowed to interrupt everything in the meeting, including someone in the middle of a speech, if you have a point of information.
- How to call a Division.
 - You do not need to raise your hand or be called on for this. You unmute yourself and say "Division." or "Excuse me, I believe there is a Division." We will immediately count the votes for the motion that has just carried. It is not impolite or unruly to do this. Do it whenever you think it is appropriate, right after the president says that "The motion carries."

Per the current ECCFA contract, "Reimbursement requests must be submitted no later than thirty (30) calendar days following the end of the academic year in which the expense was incurred."

We use the semester end date that is published on the academic calendar to determine the "end of the academic year". This year, that date is Thursday, May 15, 2025. Thirty calendar days from May 15 is June 14, 2025, but since that is a Saturday, the last day requests will be accepted is Monday, June 16, 2025.

 - Received details from VP Schopen about a FOIA request from Grades LLC requesting the following:
 - Semester
 - Course Subject
 - Course Number

 - Instructors
 - Number of students that received each grade
 - These details are apparently all considered public record in Illinois, and so the request was granted on 4/30.
 - Records for the past 3 years are now <u>publicly available</u>, along with those of many other institutions.
 - As currently constructed, the site is difficult to navigate and unlikely to gain a lot of traffic, but the data is now public.

Met with representatives from HR to clarify the initial step placement process.
 Essentially, every 2 years of FT teaching corresponds to one step, with adjunct teaching counting ½ (regardless of the number of institutions). Work experience for those in the trades is not explicitly stated in their current guidelines, but is handled on a case-by-case basis.

It's worth noting that initial step and lane placement is mostly outside the ECCFA contract.
