RECOGNITION OF VISITORS & GUESTS REPORTS –

SECRETARY'S REPORT: KIM TARVER- APPROVAL OF MINUTES OF NOVEMBER 26, 2014 MEETING (RECORDED BY JESSICA CARPENTER) PAT O'BRIEN AND MARY ELFRING MOVED AND SECONDED. MOTION PASSED.

The following motions were made electronically upon the recommendation of Luis Martinez, President and were moved and seconded by Scott Vaszily and Howard Russo: 1) Members Ruby Sanny, Dennis Lynch, Keith Lewis, Manuel Salgado, and Anu Gupta to serve on the Academic Policy Committee Panel; 2) Clark Hallpike to serve as the MAGIC Rep on the HR Search Committee for the Director of Talent Acquisition; 3) Extend the due date for the Faculty Evaluation and Tenure Handbook Committee to February 15. All three motions passed.

A motion was made electronically to extend the annual Alisa-Smith Riel Memorial Donation to her children in the amount of \$500.00 Jewel Food Store gift cards. It is not clear if the motion was seconded.

TREASURER'S REPORT: ROGER RAMEY

No changes.

PRESIDENT'S REPORT: LUIS MARTINEZ

He met with Dr. Sam yesterday.

Discussion with Sandi Brown regarding Safety Training clarifying which components are mandatory. Safety and Security are beyond the "Shots Fired" component and the sessions on back injury are important, but not required. There is still confusion. Howard's interpretation is that mandatory components must be available in multiple modalities. It seems that the "Shots Fired" component with be available online in the fall of 2015. Negotiation table notes support this interpretation of the contract. The ECCFA encourages faculty to participate in these workshops regardless of the current offerings. Being informed regarding safety in the classroom is every faculty member's best interest. The matter of thumb locks on doors and inconsistency on campus was also raised. Discussion continued regarding high risk areas.

She sent copies of the ECCFA Brochure that she and Joyce Ross created. They are developing one for IFT/AFT and there is potential for additional topics. Safety procedures under review on APC is still in process. There are also full time excess loads that Jessica has not received.

She met with Janelle to discuss longevity and the final pay in 2015. They want to hold off on longevity step to avoid revoking or asking for dollars to be returned. Discussion clarified that a hold should not occur for folks in step 20.

Payroll dates January 1, 2016 is a Friday. The proposal is to delay the pay date to Monday to avoid either 25 or 26 pay periods. 27 pay periods could have significant impact on annual income. Ellie and Luis will meet with Janelle to come to resolution.
