SECRETARY'S REPORT: KIMBERLY TARVER- APPROVAL OF MINUTES OF AUGUST 26, 2015 MEETING

Pat O'Brien moved and Ellie Swanson seconded to approve the August 26, 2015 minutes. The motion passed with 1 abstention.

Business Conducted by e-mail: On September 2, 2015, Kimberly Tarver made a motion to approve up to \$100 to purchase flowers for the funeral of Nancy Sujak, David Sujak's wife. The motion was seconded by Michele Brynelsen. The motion passed with 18 electronic "aye" votes. ECCFA Organizing Team Update – We are making progress and preparing for visioning activity to review data to provide direction to the ECCFA. In addition to the core group of senators, we invited Dan Kernler, Antonio Ramirez and David Carillo to assist with planning.

ELECTIONS & COMMITTEE REQUESTS

- Interim Dean Arun Goyal requested faculty members to serve on search committees for TWO
 Full Time Math faculty. Volunteers include Kris Campbell, Ken Beynon, Dan Kernler, Nicole
 Scherger, Catherine Moushon, Chalyce Deterding, and Armando Trejo. Diane Flahaven moved
 and Pat O'Brien seconded a motion to approve. The motion passed. Luis personally thanked the
 math committee for their assistance.
- 2. Dean Ilio Lott requested faculty members to serve on a search committee for a CIS Full Time Faculty. Glenn Mayer, Susan Timm and Helen Wang have volunteered to serve. Discussion related to Helen Wang as she is not yet tenured. Motion to table # 2 was made by Pat O'Brien and seconded by Ellen Swanson. Motion to table passed.
- 3. Marcy Thompson requested full and part-time faculty to participate in on campus interviews during the week of September 14th. SPEC Associates, a research group conducting interviews on behalf of the Gates Foundation, would like to speak with ECC faculty during their visit here in mid-September. Gates is writing a national report on student success, and ECC is being highlighted. They have asked to speak to two faculty groups one group of 6 to 8 full-time faculty, and another of 6 to 8 adjunct faculty. They'll ask both groups about student success initiatives, processes, future plans, and challenges. Beyond the full-time/part-time distinction, the groups may vary in other characteristics (i.e., gender, CT/UT focus, etc.).The full-time group

will meet on Tuesday, 9/15 from 9 to 10:30am (Room TBD) and the adjunct group will meet on Monday, 9/14 from 3:30 to 5pm (Room TBD). These meetings are very informal and will moderated by 2 researchers from SPEC. Attendees do not need to bring anything with them (other than their own expertise and viewpoints, of course!), and refreshments will be served. Discussion related to philosophical points of view and institutional process. The time slot is problematic; if there are conflicts with office hours, administration is likely open to working with faculty. Luis is recruiting participants to serve. ECCFA approval is not required; ECCFA will be responsible to recruit.

OLD BUSINESS

Amendments Committee- in response to the President's Report on 8/26/2015, Ellie Swanson,
Pat Brutchin, and Luis Martinez have volunteered to serve. Pat O'Brien moved and Sue Ford
seconded a motion to approve the committee. The motion passed. An opening exists for a unit
adjunct member.

NEW BUSINESS

- 1. ECC Foundation: ECCFA Endowed Scholarship is at \$50,349.57; Campaign contribution forms are available for distribution. How does the ECCFA share the news? Clark has set a goal to ensure every member of the senate contribute to the specific fund. The ECCFA will explore Foundation Sponsorship levels and plans to address the board and find other ways to promote.
- 2. Coat Drive for Community Crisis Center- Pat O'Brien shared that the Community Crisis Center requested that ECCFA sponsor another coat drive. Discussion: other possible needs. Luis Martinez, Rick Bonnom will coordinate the Coat Drive. David Carrillo mentioned that the HUS club is interested in supporting this activity.
- 3. Meg Bucarro, a unit faculty member has lost her home to a fire. The family has small children and is staying in a residential hotel. She is taking the semester off as they recover. Sue Ford will contact the family to determine needs.
- 4. Heidi Brelsford asked a question regarding conflict of interest with a restaurant for an upcoming party and contracting as a marketing consultant.
- 5. Sue Ford shared about a blind student who needs a Braille writing device that is estimated to cost \$10,000. She plans to investigate options. David Carrillo recommended we contact the local Lion's Club and inquire about support.
