RECOGNITION OF VISITORS & GUESTS: GEORGE ROSA, ANTONIO RAMIREZ, JESSICA CARPENTER

- Jessica Carpenter (Dual Credit Committee Update)- Survey data from English faculty included 16 responses;
 concerns and questions mirror those of senate; the English department faculty were unaware that they were included in the pilot.
- Antonio Ramirez: Statement of Support for Adjunct Faculty at Elmhurst College- Faculty Forward Chicago recently has success unionizing adjunct faculty at various institutions; they are working with Elmhurst College. Antonio is proposing a statement of solidarity be sent to the Elmhurst College President and request the administration remain neutral. They are organizing under SEIU. Bill Pelz moved and Kris Campbell seconded a motion to send a letter of solidarity as proposed. The motion passed. The senate requested to be added to the email distribution list and be made aware of other opportunities to support their efforts. Question: Are the full time faculty organized? Antonio will inquire. Kim will print the document on letterhead. *Note: Following the meeting, Antonio asked the letter to be sent when timing will have the biggest impact. He will keep us informed.
