RECOGNITION OF VISITORS & GUESTS:

Ryan Kerr, volunteered to serve as CABS senator

Dawn Munson moved to approve Ryan Kerr as CABS senator. Pat O'Brien seconded.

Motion passed.

3:30 pm: Police Chief Dave Kintz introduced himself to ECCFA. He was formerly the public information officer for the St. Charles Police Department. He discussed how ECC is very student-centered and he fully supports that

effort. Chief Kintz discussed the wide variety of experience his staff possesses. He asked ECCFA to encourage the students to use the ECC officers as a resource. He is currently working with Phi Theta Kappa to stock the ECC Food Pantry as payments for parking tickets.

He ended by encouraging people to send him ideas they have for safety training.

Secretary's Report: Given by Kimberly Tarver. She wrote the 5/2/18 minutes.

Approval of May 2, 2018 minutes.

Pat O'Brien moved to approve the 5/2/18 minutes. Luis Martinez seconded. Motion approved with 2 abstentions.

Treasurer's Report: Steve "Woody" Wood-

Honorariums were distributed. Those receiving one over \$600 will receive a tax form.

Our dues revenue will drop in the summer due to adjuncts who aren't teaching or receiving a check in the summer. Steve asked for any input regarding the budget.

Senate was made aware of the details of the latest financial statement of ECCFA.

President's Report: Kimberly Tarver- Jessica Carpenter has agreed to serve as Social Media Coordinator. Bill Akers regretfully submitted his resignation as 3rd Vice President. Kim Tarver addressed the Board of Trustees; attended COW; did Appreciation with Chocolate visits to Grievance, SLAAC, Curriculum and Faculty Development Committees; met with IFT Rep to discuss Janus, and accepted Dan Kernler's resignation from Curriculum Committee as we had one too many representatives due to the HP/MSE merger.

She has met with Dr. Sam, Peggy Heinrich, and has had phone conversation with Sharon Konny.

Kim Tarver mentioned concerns she has heard regarding the online student evaluations:

Kris Campbell has approached Lisa Wiehle and Kathy Taylor regarding what the research says about student evaluations. They will be discussing the usefulness of the data. She will be working on this with Lisa and Kathy in the summer.

Kim Tarver asked the following questions:

Has anyone been denied Professional Expense Money (PEB) and then were asked to fill out a travel form in order to be reimbursed from the PEB? Faculty should not be asked to submit a travel form for PEB money. Has anyone been impacted by the administrative procedure (April 2015) that has not been actually implemented till this year, that grades are due the Monday after classes end instead of all on the same designated day as in the past?

Faculty are feeling that there is not enough time to submit grades, especially when a class ends on a Thursday, Friday or Saturday.

1st Vice President's Report: Patrick Gordon-

What consideration is being used when recalibrating for hiring when adjuncts are being hired for full-time positions? This question was addressed later in the meeting under the category of Discussion Topics.

2nd Vice President's Report: Diane Flahaven- no report

3rd Vice President's Report: Marco Annoni – Marco has agreed to serve in this position. Kris Campbell moved to approve Marco Annoni as 3rd Vice President. Mary Arndt seconded. Motion approved.

Negotiations- (Patrick Gordon)

This committee will be meeting twice over the summer to talk about the reduction in force (RIF) list. The compensation committee will be meeting, too.

Luis Martinez wants to continue as chair of Cope with Steve Wood being the treasurer. He asked the Senate to consider having a group of people running COPE, instead of just a chair and the treasurer. There are no bylaws for COPE at this time. He requested that a set of bylaws be written for COPE – mission, responsibilities of officers, vice-chair, communications officer, etc. Those who hold these positions do not need to be full-time faculty. Officers would need to be approved by the Senate.

Patrick Gordon asked about the role of retired faculty in COPE. Kim Tarver said it would be good to address this later in the agenda under Discussion Topics.

Kris Campbell moved to approve allowing Luis Martinez to start writing bylaws for COPE. Patrick Gordon seconded. Motion approved.

Patrick Gordon agreed to be a liaison/consultant for COPE. Patrick is currently the secretary for the Democratic Party of Kane County.

ECC Board of Trustees elections are in March 2019. Luis Martinez emphasized the importance of COPE being ready to help elect candidates. Kim Tarver discussed supporting people to apply for Board of Trustees candidacy. Pat O'Brien move to approve adjournment from COPE. Dawn Munson seconded. Motion passed.

SSI Equity Coordinating Council

For the next academic year, the Equity Coordinating Council has decided to focus intentionally on **equity**, which we define borrowing language from Achieving the Dream:

In higher education, equity refers to ensuring that each student receives what they need to be successful through the intentional design of the college experience.

For FY2019, our Target Outcomes are:

- Research, identify, implement, evaluate, and scale effective student success initiatives and strategies, particularly ensuring equity for African-American students, undocumented students, and other populations
- Support and incentivize efforts that expand and institutionalize equity at ECC

We are currently seeking applications for projects that fit one of these targeted outcomes or address an equity issue on campus. Please feel free to reach out to Dan Kernler or Dr. Peggy Heinrich if you have an idea.

We sponsored several initiatives during the 2017-2018 academic year, including

- 1. Culturally Responsive Instruction Several faculty along with CETL director Liddy Hope attended a conference at the Community College of Baltimore County, and we are working on incorporating some of that content into CETL sessions in the future.
 - 2. We sponsored 20 students and 4 faculty/staff to attend the annual Illinois Latino Council on Higher Education (ILACHE) conference at Illinois State. We're also sponsoring a set of students and faculty/staff to the Illinois Association for College Admission Counseling's Sharing the Dream Conference in Joliet. The intent for both conferences was for ECC students and staff to learn better how to support our undocumented students.
 - 3. On April 13th, we invited students from NEIU to campus and ran several sessions under the umbrella Institutionalizing Support for Undocumented Students.
 - 4. While progress has been slow, we have been working to support the creation of an African American History course.

In addition, we made some decisions on two key projects:

- 1. The Faculty Research Community was institutionalized in the CETL budget for the 2019 fiscal year.
- 2. Due to lack of evidence, the Supplemental Instruction program was not extended beyond Spring 2018.

Next fall, we hope to revisit some of the original data collection we did in 2008/2009 and do some follow-up to see how we've progressed. Look for more information and invitations to attend sessions throughout next year.
