Volunteers include Manuel Salgado (As someone who has participated in all of the equity hiring trainings and someone who has been extensively involved in SSI I am uniquely qualified to assist in the hiring process for this EDI position. In addition, I have extensive experience working on Equity, Diversity, and Inclusive issues as they relate to the teaching and learning process. I am a great faculty representative, with over 25 years of experience and commitment time to Equity, Diversity, and Inclusion, Examples, Developer of the First International and multicultural recommendations for a candidate of this type of positions at ECC, (initiative first presented to the board back on 2001). MAGIC, 2nd with attempts in 2011 by Joyce. Thanks for your consideration.) Maria Bagshaw (Statement of interest: I would be interested in serving on the hiring committee for the Executive Director of Equity, Diversity, and Inclusion. This position is a very important one on campus--one that directly supports our college's values and our students. The right candidate needs to be committed to these while also having an understanding that this work is not merely performative, but essential.
