# Greetings,

On Tuesday afternoon, word came that the jury in the Derek Chauvin trial reached a verdict. Some of us gathered in virtual groups, dwelling in the shelter of each other, hopeful and fearful. We held our collective breath as we listened to the words pronouncing Derek Chauvin guilty for the murder of George Floyd. We sighed in both shock and relief.

Still, our work is not done. Our challenge is to find ways to support and stand in solidarity with our colleagues, co-workers, students, friends, and family members who are Black, Asian American, Pacific Islanders, LatinX, LGBTQIA, Immigrants, or members of other groups who are all too often victims of

violence and hate. We must resolve to address racial injustices, dismantle systemic racism, and support diversity, equity, inclusion, and social justice at ECC and in our communities.

As a union, we are committed to this work. We cannot rest. As educators, we have a unique opportunity and responsibility to address racial bias and cultural responsiveness of our students: our future auto technicians, artists, business leaders, chefs, educators, engineers, entrepreneurs, fire fighters, healthcare professionals, police officers, welders, and more.

Don't underestimate the impact of sharing a cup of coffee, a phone call, a card, or an email. Check in with each other. Some of us are not okay. Let's be there for each other.

## **Recommendations**

Following our experience with this election, the committee has four recommendations.

- 1) Putting the committee together a little earlier.
- 2) Online voting seems sufficient. Only three people took advantage of in-person voting and they were all on campus anyhow. One was just walking by and was roped in by the election judge. Keeping the election on line only will save the committee from creating 18 different ballots (Six divisions X three categories of ECCFA members).
- 3) The Election Committee might encourage people NOT to write in other people without their consent. Out of nine write-ins, four declined (all for Senate).
- 4) The Senate may want to consider setting a vote minimum for a write-In candidate to be considered for a position. Under the current system, a write-in candidate only needs one unopposed vote to earn a position on a committee or in the ECCFA Senate.
