Fielding emails Attended: CETL & textbook meetings. Attended: Collar County meeting:

- a. College of Lake County Adjuncts pay no more than ¼ %.
- b. Unemployment: SB 3009
- c. SURS calculation: SB 3046
- d. Minimum salary: HB 4361

Amends the Board of Higher Education Act and the Public Community College Act. Provides that the Board of Higher Education and the Illinois Community College Board shall require each board of trustees of a public university or community college district in this State to establish a minimum salary for instructors that is not less than \$1,333.33 per credit hour taught. Allows the minimum salary to be subject to an increase based upon a cost-of-living adjustment. Requires an annual report concerning compliance with minimum salary requirements. Provides that nothing in the provisions shall prevent the paying of instructors at a higher rate than the required minimum salary. Amends the State Mandates Act to require implementation without reimbursement.

ECCFA President's Remarks to BOT April 12, 2022

Greetings,

I'd like to congratulate Student Trustee James Allen as his term comes to an end. I hope your experience has been valuable. I can honestly say that we are better because of your service. Well done and thank you.

Like you, my term as president of the ECCFA is coming to an end. In fact, this is my last formal address to the board on behalf of the faculty. It is a bittersweet moment.

I want to extend appreciation and gratitude to members of this board and the administration for their cooperative spirit and solution minded approach to many of the issues we've successfully faced, together. Thank you to especially to college leaders Dr. Sam, Dr. Wagner, Respicio Vazquez, and Dr. Robinson. My deepest gratitude, however, goes to Dr. Heinrich and Mr. Anthony Ray.

Mr. Ray, I have served on many search committees at ECC and I am most proud of co-chairing the committee with Dr. Sam that resulted in welcoming you to our ECC Family. I can't imagine anyone in this room who wants you to be successful more than I. You have proven to be steadfast in your commitment to fairness in all of our interactions.

Peggy, much of the success I have had in working with this administration, is due to you. Thank you for being accessible, approachable, collaborative and kind. We have had some good times and some hard times. We sometimes struggled with

the where, the what, and the how... but we never struggled with the why. We've always focused people (students, faculty, staff, administrators, the community), and improving their lives through learning.

Upon being elected to my first term, the SCOTUS Janus decision threw me into the role of organizing and mobilizing. Shortly thereafter, the state of Illinois budget crisis and the underfunding of higher education and ECC, presented unique challenges for all of us in this room. Fast forward to ripping the scab off of the festering wounds of racism and the murder of George Floyd. (pause) We've struggled to meet the demands of legislation dictating delivery of dual credit and developmental education. And then, there was, and is, COVID. COVID is not finished with us, yet. Enough said. We've experienced the politicization of nearly everything, including many issues faced by this board, ECC, and by our community.

ECC has an important role to play moving forward. We must renew our commitment to improving lives through learning... by teaching ourselves and teaching others, by learning about our history, the impact of racism, and the inequities that exist in education and those that exist here at ECC. My title may change, but my commitment to that which is right, fair, and just, will not waver. May those who come behind me, and all of us, find us faithful to our commitment and to our work. People's lives are depending on US.

ECCFA Vice-President's Remarks to the Board: April 12, 2022

Some of you may have heard about or may have noticed the rat outside of ECC on McLean Blvd. for the last week.

The reason for the rat is because ECC hired a demolition company that did not pay fair wages. In fact, this company was even fined by the Illinois Department of Labor for violating the Illinois Prevailing Wage Act.

Our colleagues in local labor expressed their concerns about this company and their history, which includes the prevailing wage violations and multiple company name changes. These concerns were expressed to the Board by some of these local labor leaders last fall. But the board approved this current vendor.

Last fall, union leaders asked for the Board to consider "responsible bidder" versus the lowest bidder. Union leaders have even proposed possible language for the Board to review in regard to "responsible" bidders. So far, the Board has said nothing.

ECC's website says "We are proud to serve our students and community members...we strive to cultivate, expand, and strengthen relationships and partnerships with the communities." Infringing on our community members' right to make a fair wage contradicts this statement and our Shared Values of ethical practices and accountability, and our strategic goal of partnerships. Not only that, but not hiring responsible bidders over the lowest bidder cultivates a lack of trust.

ECCFA demands quality work, safety, fair compensation, responsibility to workers and the community in all aspects of the college.
