I started as an adjunct in the ECC paralegal program in 2011 and was hired full-time in 2013. I've appreciated the hard work our negotiations teams have done over the years and enjoyed being able to bring them a meal during the negotiation process several years ago. During the season of negotiations, I know it is a grind. For those who have negotiated during COVID, it has been a never-ending grind. But it's important work because the Contract is the foundation of the union's relationship with its members and administration.

#### Why Negotiations?

As a lawyer, I take particular interest in contractual language and drafting strategies. I was an English major in college and have taught our ECC Legal Writing class for many years. When I think about adding value to the ECCFA, I believe my strength is in developing the language of the contract to reflect the intent of the parties. While I have experience negotiating and drafted contractual language as an attorney, I don't have experience doing that work in a collective bargaining setting. I'm interested in learning more about union negotiations so I can request to serve on a future negotiations team for ECCFA.

#### What about SBCT Senate Representation?

For those wondering why I have not requested to serve in a Senate roll in ECCFA first before requesting ULI training, the primary reason has been a scheduling conflict.
