2. APPROVAL OF MINUTES

- a. Tammy moved to approve the minutes from the February 22, 2023, senate meeting. Janice A. seconded. The motion carried.

3. TREASURER'S REPORT: STEVE "WOODY" WOOD

- a. The treasurer's report was accepted.

4. PRESIDENT'S REPORT: LORI CLARK

- a. Attended: full contract negotiations, grievance committee, VP/CHRO meeting (topics: safety drills - active shooter, W-2 issue, Academic Technology Committee, professional expense reminders), and meeting with Dr. Sam (topics: fitness Center, enrollment, 403B/457B provider change).
- b. W-2 Issue. Senators discussed the W-2 error and its impact on preparing tax returns.
- c. Active Shooter Training. The college is looking for the active shooter training brochures they've supplied in the past. They will send those out again.

- i. Negotiating Status. Things are going fine. Five items are still open, not counting the salary schedule. Most things are settled. Hopefully, we will have things wrapped up within a few more meetings.

- i. Class Cancellations. A grievance related to class cancellations was filed and resolved by HR. The faculty member was made whole. Grievance issues can be directed to Peter Han or Tim Anderson.

c. Project Backpack: Tammy Ray

- i. Fall 2023 Fundraising. Project Backpack is coordinating fundraising efforts for backpacks, school supplies, and resources for students in need who will be enrolled at Elgin Community College or School Districts within ECC's District 509 (School Districts: U-46, D300, D301, D303, or D20) for Fall 2023.
- ii. School Distribution. Participating school districts have requested that donations be made directly to the schools to create easier access for families. As much as ECC has enjoyed hosting the event in-person, direct distribution better serves the families within those school districts. Fall 2023 fundraising efforts will be used to purchase backpacks and pre-assembled supplies in bulk to be delivered to the schools. ECC students will have access to Project Backpack supplies through the ECC Food Pantry.

- a. Faculty Development Form. The issue with the submit button has been fixed.

7. NEW BUSINESS

- a. KCT Address Collection. The contract between ECC and KCT Credit Union, to establish a KCT site at the ECC library, gives KCT faculty and student contact information for promotional materials. There is an opt-out option. HR will provide opt-out information. ECCFA will share it when it's available. Senators expressed concern that ECC allowed a contract term that gave third-party access to personal faculty and staff information.
- b. 403b/457b Provider Change. HR is working on a FAQ document for employees. Senators had questions about the change and its impact on employees. Clark Hallpike was part of the review process. Keep sharing your thoughts and questions. HR will be providing additional information.
- c. Academic Technology Committee. The college is working on reviving this committee which works with IT on technology in the classroom. Senators discussed the committee's past work. Len moved to recommend a small, informal committee if the academic technology committee is revived. Stacey seconded. The motion carried. The committee is in the supplemental chart, so the faculty co-chair should be compensated.
- d. End-of-Semester Parties. Senators discussed the inclusion of administration at the ECCFA parties at the end of each semester. Since the summer picnic has not taken place for several years, which was ECCFA membership only, there are no ECCFA-only socials. Ryan suggested polling members to decide what to do with ECCFA socials in the future.
