- b. **Office Hour Spreadsheet Issue.** Patrick notified Senators that the SBCT office hour calculation spreadsheet has a bug. It's not calculating hours correctly.
- c. **Renovation Issues.** Susan shared the difficulty she has experienced with the renovations. She was supposed to be able to move back in, but her office is getting ripped out again because it wasn't constructed properly. She isn't able to move back in. Lori will share this experience with Peggy and Anthony.
- d. Academic Calendar Comparison Waubonsee. Luis reminded Senators that we have pushed the administration to close the Wednesday before Thanksgiving since many students don't attend. High schools have it off. With the number of dual credit students we serve at ECC, this is a big disruption. Luis learned that Waubonsee gets the entire week off without adding extra days to the front or end of the semester. How is this possible? We should continue to push for that day(s) to be removed.
