# 403b/457 Retirement Team Report for 11/6 Senate Meeting

The IRS has released the 2025 contribution limits as follows:

#### 403(b) contribution limits:

This is the maximum amount someone can contribute to a qualified retirement plan during the year, through pre-tax and/or Roth after-tax contributions combined.

**2025: \$23,500** 2024: \$23,000

### 457(b) contribution limits

This is the maximum amount someone can contribute to a qualified retirement plan during the year, through pre-tax and/or Roth after tax contributions combined.

**2025: \$23,500** 2024: \$23,000

# **Catch-up contribution limit:**

This is the maximum catch-up contribution amount someone age 50 and above can contribute during the year.

**2025: \$7,500** 2024: \$7,500

To stop, start or change your contribution(s) to ECC's 403(b) and/or 457(b) plan, please log on to your account with ECC's single source providers for these plans, OneAmerica: https://pages.oneamerica.com/ECCRetirement

It is important to remember that contributions to the SURS 457(b) plan(s) (or other 403(b)/457(b) plans) count toward the overall limit per plan type. Be sure to keep track of your contributions across any plans you may have.
