The Maintenance of Health Benefits grievance (#2007-2008-1) is now settled. ECCFA members involved in the grievance will receive a check in the amounts they each self-reported to the Grievance Committee. The committee in turn reported that information to Dr. Spahr who arranged for the repayments. The checks are cut separately from members' biweekly pay checks. Should affected members not receive the check within two weeks, please let a committee member know and we will follow up. One member reported receiving the check at home this past Monday

The college agreed that if additional ECCFA members come forward, no later than June 30, 2008, with the same kind of HMO costs and provide their own receipts to verify the expenses to the HR Department, then the administration will repay those members too.

A buffet luncheon at a cost of \$10.00, payable at the door, will be followed by a program on "Retirement Realities" presented by Molly Hofer of the U of I Extension Service and a short business meeting to receive and act on a report from our nominating committee.

This program **is not** financial but rather on the personal fulfillment aspects of retirement. Why this program? We all owe it to ourselves and our loved ones to plan, not only for the financial but also personal development realities of retirement, even while struggling to keep up at early and midpoints in our careers. Those of us who have retired and experienced those frantic last few work years trying to maximize annual income found even less time to review whatever dreams we had of taking time to grow in new ways. Retirees among us are traveling, playing a bit, practicing arts and crafts, building businesses, but also giving back to loved ones in child and elder care as well as volunteering in many wonderful ways: sharing skills and knowledge, helping rebuild after

disasters, fighting in the political process and against poverty. We want you to enjoy the same options and opportunities.

Our currently solid and hard earned pension plans and the freedom of choice to use the time they provide are under attack. The Ryan and Rezko trials, paralysis in Springfield, and the “recession” remind us of how fragile our “secure” future can be. TRS fought off predatory fund managers. SURS was not so threatened in the last round of corruption because lower on the shark hit list and very well managed by Executive Director Dan Slack and the SURS Board. The redesigned SURS website and counselors are your best sources for personalized information about financial decisions and fund security. Click on [www.surs.org](http://www.surs.org) and look it over. All our plan options are well managed, but you need to make the right choices. Especially recommended is a monthly visit to read the *SURS Advocate*. The March issue includes an excellent explanation by Dan of the critical need for full funding of the state share in this and in the next few fiscal years.

Those in the Traditional Plan with defined benefits enjoy provisions which make our pensions such a big factor in choosing public over higher salaries in private sector employment, i.e. state pension income is currently exempt from Illinois income tax and increases by a 3% annual cost of living allowance. These factors as well as under funding or controlling fund investment and health insurance make all state pension funds very tempting political targets. A coalition of Illinois employee unions and retiree associations is working hard in Springfield on your behalf. Both membership and lobbying separately through PICs are legitimate and vital activities. This is why the state office of SUAA launched a major recruiting effort with university and community college employees over the age of 40. Please consider acting on that appeal. ## Senator Hallpike Served ECC Faculty Well Dennis Lynch

Clark Hallpike finishes his tenure on the Faculty Senate this month, and ECCFA will be the lesser without his presence there.

On the Senate, Clark was a voice of reason and restraint, and was a model of dignity and decorum. Clark refused to buy into the “Us versus Them” mentality that too often holds sway in union/management conflicts. He refused to see all administrators as evil or villainous.

When some of us fellow senators would use words like “dumb” or “stupid” to describe administrators or their ideas, Clark would have the courage to speak up and to remind us that such language is not only demeaning but also unprofessional.

What Clark showed is that it is indeed possible to disagree with certain acts of administrators—or even to disagree with fellow union members--without condemning them as individuals or disrespecting them as human beings. It’s a message we all should remember.
