## Highlights of the New ECCFA Contract

**On January 14, the Board of Trustees ratified the ECCFA contract that was ratified by the faculty during the Opening Day luncheon on January 9. The three-year contract was tentatively settled on December 19.**

**Highlights of the new contract include:**

- **Full-time faculty will receive a 1.5 percent raise to the base in 2014, a 2.25 percent increase in 2015, and a 2.5 percent increase in 2016.**
- **Unit adjunct I and II faculty will receive a 2.25 percent increase in 2014, a 2.25 percent increase in 2015, and a 2.5 percent increase in 2016.**
- **Adjunct faculty members will also have the opportunity to request sabbatical leave.**
- **Health insurance costs will increase for ECCFA members. Individual coverage will increase to 11 percent in 2014, 12 percent in 2015, and 13 percent in 2016. Family coverage will also increase to 21 percent in the second year of the contract and 22 percent in the third year of the contract.**

I don't really remember much about my maternal great-grandmother, Jessie Laughlin, but one thing that sticks out in my memory is her involvement in The International Ladies Garment Workers Union (ILGWU), Central States Region and her work in garment factories in Pana, IL and then Hillsboro, IL.

Since Grandma Laughlin (as I called her) died when I was sixth grade, she and I never had an opportunity to discuss her role in the union. Through my grandmother and my mother, I have learned that she was a proud member of this union and was actively involved. My mom has told me that every summer Grandma Laughlin would go to Wisconsin for union meetings and classes. These were events that she looked forward to and were very important to her.

Along with being a proud member of the union, my great-grandmother was a musician, playing the organ at her church, frequently playing gigs at an area restaurant, and she and some of her friends were members of a Kitchen Band, where all of the instruments they played were made up of items that would be found in the kitchen. Somehow, she had time to do all of this while being so involved with the ILGWU. She truly was a remarkable woman.

I learned from my great-grandmother that there is nothing wrong with being a strong, independent woman who stands up for what she believes in. That is what Grandma Laughlin did through her union work. I also learned about passion—passion for a job, passion for a cause, passion for equality and equity.

Interestingly, parts of my life are parallel to Grandma Laughlin's life. She was a proud member of the ILGWU; I am a proud member of the ECCFA. She attended union classes in Wisconsin, and I have attended Union Leadership Institute classes. We both recognize the importance of the union in regards to making sure that everyone is treated with respect and treated fairly.

Knowing how important the union was to Grandma Laughlin, I like to think that my involvement with the ECCFA and the fact that I understand and support the ideals of the union would make her a happy woman. I wish that I had been given more of an opportunity to share this part of my life with her and for her to share this part of her life with me. I have no doubt that she is somewhere, smiling and playing "Solidarity Forever."

## Writers Center Welcomes Bob Shacochis

Writers Center Reading Series 2013—2014 will host Bob Shacochis in a special Tuesday night reading on February 25, 2014 at 7:30 p.m. in H 142.

Shacochis holds an MFA from the Iowa Writers' Workshop (1982) and specializes in fiction and non-fiction. His first collection of stories, *Easy in the Islands*, won the National Book Award for First Fiction in 1985, and his second collection, *The Next New World*, was awarded the Prix de Rome from the American Academy of Arts and Letters in 1989. Shacochis is also a former columnist for *Gentleman's Quarterly* and a contributing editor for both *Outside* and *Harper's*. A collection of his columns for *GQ*,



*Domesticity: A Gastronomic Interpretation of Love*, was published in 1994. *Swimming in the Volcano* was a 1993 National Book Award Finalist. *The Immaculate Invasion*, a chronicle of the 1994 military intervention in Haiti, was a finalist for The New Yorker Magazine Award for best nonfiction of 1999. He has also received a James Michener Fellowship and a grant from the NEA. His newest novel, *The Woman Who Lost Her Soul*, was published in 2013 to great critical acclaim, affirming

Shacochis as an important voice in contemporary fiction.
