## **ECCFA President's Message**

At ECC, we're fairly insulated from outside pressures. Periodically, state legislation or budgetary problems can impact us, but we're on solid financial footing, we have a strong faculty union with a good administrative relationship,

and we're known around the state and country as a quality institution of higher learning.

But now, recent actions at the federal level have the potential to significantly impact our work. VP Schopen and President Heinrich have relayed what they know about the impact of the recent executive orders, but we're largely in uncharted waters.




I haven't shared much of these conversations with anyone outside of the ECCFA officers, primarily because there is just so much we don't know. We do know that <u>a letter</u> was sent to all education institutions that receive federal funding, which includes ECC. Not only do we have millions of dollars in grant-funded programs, <u>nearly 3,000 ECC students</u> receive Pell Grants. But the letter is intentionally vague, likely hoping that institutions will self-censor in an act of anticipatory obedience, a strategy that <u>the AAUP strongly advises against</u>.

What does this mean for us as faculty? Right now, we don't know. Our senators and representatives have shared that this is indeed serious, and there are programs that we all value that are at risk of changing or being removed entirely - not because our college administration has decided to obey in anticipation of whatever nebulous rules the Department of Education decides it wants to apply, but in recognition of the stark reality that the removal of all federal funding would cause significant harm, and so ECC may have no choice.

What can we do? Maintain our solidarity. We know the vital mission we serve here at the college, and we know we must serve ALL students. Continue the good work. Keep advocating for what you believe in, and encouraging others to resist external pressures whenever feasible. And keep an eye out for plans to mobilize. We hope to periodically show the public (and ourselves) that we still have a voice, and we still believe in what is right for students. The faculty at ECC have served students for 75 years, and we will continue to serve them long after the current administration has passed.
